Okay. Can you tell me what a typical day was like at school? From the time you guys came in until you left? What was a typical day like?

We had devotions in the morning and which always ended with prayer. And then we went to our classes, and then there was a ten o'clock, I think at ten o'clock, a morning recess. And then we had lunch. And about at 2 o'clock, we had another recess and it – school was open and all our bathroom facilities were outdoors. We didn't have any indoor plumbing and we had a potbellied stove and then we had wood and we had coal.

The county supplied the coal, whanot. And we didn't have any water. At first they went down to a neighbor's spring to get the water and then later they drilled us a well. Of course you had to pump the water from the well.

And what about lunch? How was - how were your meals provided for in lunchtime?

In the next classroom, we had history and English. And we had geography. And we did a lot of reading.

Do you remember the books that you used? Do you remember the condition of the books or can you describe the books and materials that were used in them in the school?

And all they were awarded ribbons, blue ribbons and, you know, ribbons, according to your work.

Okay. And for the school year, was it a typical academic year, like now? Did you - what month did you begin and what month did they let out?

Geraldine Pettigrew

Well, we began in September, and school was out early June, the first part of June.

Are there any other memories that you have of attending the school that you would like to share with us?

Geraldine Pettigrew

No. Well, when we when we came down here, we had to ride the bus. That was quite an experience. We had to ride the bus. And you met with the other students from all over the county and what not. And that was good because you met other people, you know, and what not. And I really enjoyed it. One of my favorite teachers was, the gym teacher, because I had wanted to go to school to be a gym teacher.

And how was discipline handled at school if you didn't finish your assignments or if any of the children acted up? How was discipline handled in the class?

Geraldine Pettigrew

at one time, if the boys didn't behave, the principal spanked 'em. When he spanked 'em, he says "Sonny, you know better than that!"

Did you have homework?
Geraldine Pettigrew
Yes.
Tonia Merideth
And you completed,
Geraldine Pettigrew
I did. I was - I wasn't the top person in the class. But when the exam time came, I was exempted from the final exams.

Well, now I'm really - I'm not sure because I usually tried to finish my mine and whatnot. But I do know,

And so then the next questions that I have are about the community and maybe some of the opposition or other experiences that you remember while you were going to school. Do you remember having some issues race wise in the community because of segregation? Do you remember any instances of that or experiences? While you were going to school?

Geraldine Pettigrew

No, because we went to our school then others went, you know. But where we live, was just Black in that section. There only was one other couple, a white couple that lived there, but they didn't live over in the other section with the other white people. It might've been because of their income. I'm not sure.

Tonia Merideth

So in thinking about going to school at that time, what did you think about education then and your experience then and what do you think about it now?

Geraldine Pettigrew

Well, I had always wanted to go to college. And after high school, my parents weren't able to send me. And we worried didn't know anything the scholarships and what not, so I didn't go to school until after I was married. And then I went to, you know, the school then.

So when you were attending the Megginson School though, what did you think about the education that you were getting at the time?

Well, I really didn't know. I thought I was you know, everything was all right. I was just in my early teens. Well, like 13 and what not, you know.

And so looking back on it now, what do you think about the education that you were getting?

Geraldine Pettigrew

It could have been better. It could have been better.

And why do you say that would - what could have been - what things could have been better at the school you were going?

Geraldine Pettigrew

Well, the reason I said it, is because when I got to high school, high school, we didn't have any typing or any office skills offered to us. Now, we had home economics for two years. That's what the girls say.

Geraldine Pettigrew

I think it's very good. It's very good. And it should be education for the people that come home (?) to let them know what we went through when we were coming.

So when when you were attending school, did you notice the differences in the schools you attended and the white schools?

The white schools, were offered office skills and whatnot. And the ones that didn't go to high school, could go and get a job, like in the stores and whatnot. And we weren't because we didn't have the skills and whatnot. And if we wanted to work, we either went to the laundry or to work for somebody in their home, taking care of their children or cleaning their homes or whatnot. That was back in 1946.

Did your - do you remember your parents impressing upon you the importance of education? Did your parents really push you guys to.

No. But they made sure that we finished high school - made sure that we finished high school. But like I said, they weren't able to send to college. We didn't know anything about scholarships or anything. And nobody informed us. And I guess maybe we should have inquired more, but we didn't. And I just wasn't able to go until after I got married, you know, my husband saw that I went to school.

And I'm sorry. What was the name of the school that you went to after you got married?

Geraldine Pettigrew

After I got married, I went to Central Virginia Community College. And I got my associate's degree from there.
